# **Workshop Learning Objectives**

- 1. Conduct a history and physical exam for first trimester bleeding to help distinguish normal from abnormal pregnancies.
- 2. Interpret ultrasound and labs results to diagnose early pregnancy loss (EPL).
- 3. Describe the three options for management of EPL:
  - a. Expectant management
  - b. Medical management
  - c. Surgical management

#### **Terminology & Background Data**

Slides 3-4 goes over the terminology surrounding EPL. Slide 5 provides some background data on EPL broadly.

#### Signs, Symptoms, and Diagnosis

Slides 6-10 go over the signs and symptoms of EPL, the 1st Trimester Bleeding Algorithm, Algorithm for Diagnosis of Pregnancy of Unknown Location, and diagnosis with ultrasound findings.

On Slides 7&8, refer participants to the algorithms in their Case Studies Learner's Guide, Appendix A.

## **Introducing Case Study: Jennifer**

On slide 11, you will introduce outpatient management of EPL and counseling of all three options: expectant management, medication management, and procedures.

Slide 12, introduce patient case study with Jennifer.

Slides 13-15 explores diagnosis.

Slide 16 discusses how to counsel Jennifer and address concerns or myths.

Slides 17-20 cover expectant management of EPL.

## **Medication Management**

Slides 21-29 cover medication management of EPL, with a focus on using mifepristone and misoprostol.



# Manual Vacuum Aspiration (MVA)

Slides 30-32 cover in office MVA procedures.
