Telehealth for Reproductive Health Care Workshop

Overview

This workshop includes both a didactic presentation and a group discussion on how clinics and clinicians can provide reproductive health care through telehealth. This lecture outlines adjustments that can be made to clinic and clinician practices while also continuing to provide patient-centered services. The workshop content should run approximately 1 hour.
